

Terms & Conditions of Entry for ProFX Awards Dubai 2024

1- Nomination Entry Deadline:

- Nominations must be submitted by May 9, 2024, to be considered for the ProFX Awards Dubai 2024.

2- Traders' Trading Period:

- The trading period for traders acting as judges will conclude on May 25, 2024.

3- Voting Period:

- Voting for nominees will commence after the nomination deadline.

4- Entry Fees and Deadlines:

- **Early Bird Entry:** Entries submitted before June 14, 2024, will be charged an early bird administration fee.
- **Standard Entry:** Entries submitted after the early bird deadline but before June 28, 2024, will be charged the standard administration fee.
- **Extended Entry:** Entries submitted after the standard entry deadline but before July 5, 2024, will be charged the extended administration fee.
- No entries will be accepted after the extended deadline of July 5, 2024.

5- Submission Requirements:

- Ensure compliance with the criteria for the awards category entered.
- Provide evidence such as quotes, figures, and statistics to support nominations.
- Include at least one company and/or client logo in JPEG or PDF format, under 2MB.

6- Acknowledgment and Responsibility:

- All completed entries will be acknowledged online upon submission and payment.
- The organizers are not liable for the loss or damage of any entry.

7- Judging Process:

- Judges' decisions are final, and no correspondence or discussion will be entered into regarding shortlisted nominations or winners.

8- Entry Title Requirements:

- Entry titles may be shortened for publication.
- Please adhere to the entry format stated in the rules.

9- Publication Approval:

- Entries will not be published without prior approval.
- Winners may be asked to allow their entries to be made public for future marketing and promotion.

10- Deadline Extensions:
